## ***Mayor of The People's Will or Mayor of Special Interests?***

### **THIS MONTH'S MEETING**

Speaker for this month's luncheon at **12 noon on Tuesday, July 1** at the Clarion Hotel on E. 70th Street will be **J. Keith Gates**, conservative candidate for Louisiana Public Service Commission, District 5 who believes in lower rates, better service, and less bull.



Keith was born in Natchitoches, raised in Goldonna, and is proud to call North Louisiana home. Keith is a graduate of Lakeview High School where he was active in the FFA, achieving the American FFA Degree. Keith attended Northwestern State University and the Louisiana State University Paul M. Hebert Law Center in Baton Rouge where he received both a

Juris Doctor degree and a Bachelor of Civil Law degree. After law school Keith clerked as a research attorney for the Hon. Justice Jeffrey P. Victory of the Louisiana Supreme Court in New Orleans, the highest court in Louisiana. Keith worked in all areas of Louisiana law including appellate, constitutional, criminal, election, family, property, sales, workers' compensation and many others.

In the summer of 2011, Keith left for Washington, D.C., where he and three other attorneys founded a non-partisan organization that uses public advocacy and legal reform tools to ensure greater transparency in government, protect taxpayer interests and promote economic freedom. Thereafter, Keith came home to North Louisiana to fulfill his dream and open the Gates Law Firm. Keith represents clients in many different types of matters that run the gamut of Louisiana and Federal law.

Keith is active in his community, teaching Royal Ambassadors at his local church, speaking to local school groups about being an attorney, and holding membership in Goldonna Lodge in Goldonna, Hope Lodge in Lafayette, and O.K. Allen Lodge in Winnfield. Additionally, Keith serves as the Grand Organist of the Grand Lodge of Louisiana, Free and Accepted Masons.

Keith is an active outdoorsman and is a member of the National Rifle Association (NRA). In his words, "I have a second amendment right to posses a firearm, and I use it."

## FROM THE CHAIRMAN

Dear Fellow Republicans,



While national politics will continue to command our political willfulness to defeat Mary Landrieu here at home, and preserve the conservative principles that we hold dear throughout this great state, there are other, important threats to our community, that deserve our attention. One such threat is the utter disregard of the people's will, by both the Shreveport Mayor and City Council, last month.

By a vote of 5-2, the City Council allowed the continued development of a subdivision that is directly in the path of the Inner Loop Extension (via 3132) to the Port of Caddo-Bossier, despite the election in 1996 where voters approved spending their property tax dollars, through a 1996 bond issue, for this highway project. There are lots of reasons why 64 percent of the voters back in 1996 chose to spend their tax dollars on the extension: Increase safety for residents and others who travel on East Flournoy Lucas Road, encourage traffic to the Port by offering a more

convenient route with a higher speed limit, encourage future development along the Inner Loop, reduce industrial traffic from Youree Drive and Bert Kouns – and the list could go on and on, of course, to explain the majority vote favoring the extension of the loop.

But let's get something straight here. This is not just about a highway. Or higher property taxes (although we have the highest in the state). It's not about economic development (although our population has declined now to below the 1980 census population). It's not about politics (although every politician from Bossier City to Bogalusa has had some involvement in this matter). It's not about the financial interests of a few landowners (although this perception of Shreveport is partly why so many are moving away, and to communities where they feel ordinary folks, like themselves, can be heard and make a difference).

It's about the will of the people, and according to Thomas Jefferson, the will of the people is the only legitimate foundation for any government. In our Shreveport city government, the will of the people has been lost, however, and so it seems the very foundation of city government itself.

It's plainly about the will of the people, and our community telling the mayor, and the City Council, that we're tired of the old attitude of "give us the money, and we'll tell you what we spent it on later." Now we can't make chicken soup from chicken poop, or otherwise undo all of the knots this matter has been tied up into. But we also don't have to make the same mistakes going forward for our community. Next time, it must be the will of the people — not special interests — that choose the path forward. And that's whatever road you choose.

## GEORGE BURTON, SR.

Most of the younger generation will not know or remember Republican George A. Burton, Jr., who passed away on June 10 at the age of 88. George was involved in numerous civic activities and brought considerable prestige and respect to the Republican Party at a time when, as the saying goes, Republicans were meeting in a phone booth. (Some of our younger folks will not know what a phone booth was). George was the first Republican in Louisiana to be elected to a major full time office when he was elected Shreveport Commissioner of Finance. He served as Chairman of the Caddo PEC from 1960-1980 and was elected to the Republican State Central Committee 1972-1980 and served as Secretary during that time. He was appointed Chairman of the Caddo Board of Election Supervisors in 1978 by Democrat Governor Edwin Edwards and served in this capacity until his retirement in 2008.

## LA. GOP ENDORSES CASSIDY

In announcing the endorsement, Villere noted that it's rare for the state GOP to get involved in a race involving multiple Republicans – the last time it was done was the 2007 governor's race when the party endorsed Bobby Jindal – but a majority of the members of the state central committee voiced support for a Cassidy endorsement in writing, and therefore the executive committee voted to execute the endorsement per party rules.
