## Does Party Matter?

### THIS MONTH'S MEETING

Our topic for this month's luncheon at **12 noon on Tuesday, December 1, 2015** at the Wyndham Garden Hotel (formerly the Clarion Hotel) on E. 70th Street will be **"Does Party Matter?"** From the "Republicans for John Bel Edwards" voters, to those who say that it is more important to vote for the person (rather than for their Party), the dissension within the Republican Party on this subject was none more evident than in the gubernatorial run-off on November 21. Many feel that this called into question the very significance of our Party system in this country, especially as we dive head first into the final leg of the 2016 election season in January.

Political parties are essential to democracy because they check abuse of power by elites and keep the government accountable. Just as competition prevents one business from gaining monopolistic control over the market, competitive parties

prevent elites from gaining control over the government by forcing the government to appeal to the majority of voters.



A strong political party system, then, promotes equality in a way that government programs or handouts never could, and empowers the least among us.

PACs and special interest groups, on the other hand, have the effect of widening the disparity in political equality. This is why the middle class feels forgotten, and why so many feel that their political party has left them behind – after all, they simply aren't the center of attention. This will be a lively presentation, and discussion, from all those attending with an opinion on the matter as we enter the 2016 election year.

## FROM THE CHAIRMAN

Dear Fellow Republicans,



The influence of PACs in our Louisiana elections this year has been profound, and perhaps a foreshadowing of the possible escalation of such influence, considering the success of such influence in 2015. George Soros' total investment in the Caddo Parish District Attorney's race was over \$900,000. And his candidate won.

Former Mayor of New York City, Michael Bloomberg, invested almost \$1.5 million in our state's BESE races. And depending on who you talk with, all of his candidates won, insofar as they were candidates that supported (or have supported) the Common Core standards, as well as charter schools and publicly funded vouchers.

The question for many, many voters was, "Why would so many, from so far away, invest so much, in our state's elections?" Many wondered what such huge sums of money were used for? While our imaginations may run wild with speculation as to the answer(s) to this question, it seems likely that such had a significant effect on early voting, though. Voter turnout was a little bit higher — at just under 40 percent — in the runoff than the primary, but that was almost entirely due to a significant boost in early voting.

In fact, NOLA.com reported that voting on election day in the primary and runoff was basically the same — around 30 percent. But early voting jumped 36,000 votes from the primary to the runoff, accounting for 92 percent of all increased voting from the primary to the runoff. Additionally, voter turnout in north Louisiana was lower than in other parts of the state.

Here in Caddo Parish, specifically, we had record early voter turnout, says Ernie Roberson, Caddo Parish Registrar of Voters. He reported that his office recorded 10,400 early votes, and that his office likewise received the highest number of mail-in ballots

ever — 3,102. And of the early voting, Democrats dominated with 5,896 early votes compared to Republicans with 3,485 and other parties trailing with 1,019 early votes.

Simultaneously, there are a record number of voters registering as "no party" (twice as many as those registering as Republicans or Democrats, combined), and a rising tide of Republicans, who voted against David Vitter, and dispensed with Party affiliation, saying it was more important to vote for the person, than the Party.

Even Party loyalists can agree that all voters should put principle before Party, but is this a case where the Republican supporters of John Bel Edwards are in the right church, but in the wrong pew? Or should these Republicans consider joining the Democrat Party, or some other Party, instead?

Are they part of a more malignant condition that is weakening our Party system, which is allowing the media and the special interest groups to take the place of the political party system completely in our country? Or does it really matter, at all?

Edmund Burke deemed it impossible for legislative bodies to make policy without forming coalitions. But if we keep weakening our Party system, won't we keep getting what we're getting? Shouldn't we come together as a coalition — as a strong political party — the people's party — and reclaim our nation from the media and the special interests?

### *Join The Ranks!*



## THERE'S LESS CHRISTIANS, BUT...

As we begin the Christmas season, there are about 41 million Americans, or 17 percent of the adult population, who are Christian consumers that spend about \$2 trillion annually, and will spend roughly \$30 billion this Christmas season. The American Family Association, a nonprofit that promotes conservative Christian values, publishes an annual "Naughty or Nice list" that ranks retailers based on how frequently they use the word "Christmas." "Nice" retailers this year include Wal-Mart, Hobby Lobby, and Lowe's. "Naughty" ones include Barnes & Noble, PetSmart, and Staples.

## CO-MISSION IMPOSSIBLE?

As you all may know, there are five (5) brand-new Caddo Parish Commissioners that will be sworn-in soon, including frequent Caddo Republican luncheon attendees, Mario Chavez



and Mike Middleton. They represent a new hope for our community, especially those who feel that past Commissioners were far more interested in what was best for them, than the citizens. But the new Commission will face a considerable amount of scrutiny, and a mountain of challenges to improve the image of the Commission with the voters of Caddo Parish. Among those challenges is a lawsuit that was filed by Elliott Stonecipher and local attorney, Whitney Pesnell. The Caddo Parish Commission has spent \$46,000 thus-far in legal fees in this lawsuit, which challenges the legality of the retirement benefits that Commissioners voted themselves, purportedly in contravention of state law, but with the approval of the Commission's attorney, many years ago. Stonecipher reports that he has confirmed that the person directing the Commission's litigation, is ex-Commissioner (and now Shreveport City Council-member) Stephanie Lynch.

Stonecipher is reporting that Ms. Lynch believes that "Commissioners should be 'full-time,' and paid \$60,000 per year plus 'benefits,' regardless that they work perhaps 12 hours a week and exclusively govern only 20% of parish residents." He reveals that in CPERS retirement benefits alone, "Ms. Lynch has scored more taxpayer money than any other Commissioner. Our contributions of 'match' money to her retirement total \$30,157.13." There is little doubt that the new Commission shares Ms. Lynch's perspective, but the continued attention from some voters are making a significant difference, as the election results certainly reveal.
